**List of required documents:**

- Original or certified copy of the Bareboat Charter (certified by an attorney at law or by two witnesses or by Notary Public)
- Rights certificate for the owner and the charterer
- Written approval from the permanent ship register that the vessel is entitled to fly the Faroese flag in the charter period
- Transcript from the permanent ship registry concerning the registered owner of the vessel
- Tonnage certificate and notification about the power of the engine from the Faroese Maritime Authority (This is only required the first time the ship is registered)
- Fee for registration of the Bareboat Charter and certificate of nationality

All information provided in this notification must be printed or written in block letters. The notification must be submitted to the Faroese Ship Registry.
